- Cooks Cove has to be replaced and we now have a quote on the new system for \$165,600.
- We have to replace a culvert in behind the Church and the brook there may need to be cleaned out.
- According to the union, we no longer have a third person for call-in so we have to advertise for another person since we are unsure as to the status of our senior operator.
- We still have not received any feedback on any of our funding applications.
- We have received a portion of our stimulus funds.
- I have put in a claim with our insurance company for our Cooks Cove plant and I am expecting to hear something soon.
- We are now having problems with our loader and someone from Cat is coming to look at it.
- We have been approved for 4 summer students for a total of 1120 hours but are still waiting to hear from the provincial application.
- I have spoken with our recreation director and she feels we can go ahead and have our soccer program and possibly our day program but rather than four days a week, it will be two days a week due to cleaning requirements. She would like to begin the first week in May to have all planning and preparation done when the program begins. She can handle all planning on her

own but needs her assistant once the program starts and 5 students to maintain the soccer program.

- We have a person coming this week on Wednesday and Thursday to document our assets for the asset management program.
