They have received approximately \$10,000 to date in donations and would like to hire David Hopkins and Scott Coish to do more work on the trailway. He requested both the Town of Old Perlican and the Town of Bay-De-Verde to match \$5000 each which would be sufficient funds to complete the trailway, when completed this trailway could also be used as a secondary emergency route. They are also looking into joining together with other trails and may eventually look for Government funding. Carl is in consultation with Adam Hindy of Conception Bay trailway and will be looking into various routes to travel from Hayrides track to Herder Street.
