- We are also looking at having a kids clinic with Broken Earth if they can acquire the Pfizer vaccine.
- -The advertisement for the Royal Greenland project will be finished on Saturday. All concerns to date have been addressed, however there will be a meeting called next week to address any further issue(s) and to move forward.
 - -We have tendered for our garbage collection.
- -We had to put out a tender for our new pick up truck because the price quoted and delivery time could not be guaranteed. However, we may be able to have it in 6-8 weeks with a slight increase in price after tendering.
