WASTEWATER

- All Municipalities/Towns are to reduce toxic substances going into the ocean to meet the Federal Wastewater Effluent regulations. This became law in 2012. All Towns were/are expected to monitor their outflow and report findings to the Federal agency responsible for this project in order to determine their status.. Towns were then asked to plan and have systems upgraded, if necessary, by an identifiable date known as the Transitional Authorization date. Old Perlican was given up to the year 2040 if an application was submitted. No application was submitted at that time. The next round of applications will be in 2023. It is strongly suggested that due to the magnitude of this project we plan on tackling this issue as soon as we possibly can.




