-We will be applying for the Eastern Regional Service Board clean up grant.

-I spoke with the Ambulance Supervisor. She informed me that she is resigning the position of Ambulance Supervisor effective immediately.

-Our dump truck had to be taken to Town- St. John's, on a float, due to Carbon buildup that was not getting burnt off. The company has suggested we take it for a long run (15 min/100kms/hr)at least once a month to burn off this carbon build up.

-The tender for the waterline project is being advertised and will soon be concluded, then hopefully awarded as soon as possible.

-The insurance claim has been completed. We have been offered \$24,900 towards the Cooks Cove Plant repairs.

-I am also filing an insurance claim for Long's Hill Booster Station.

-The Town auditors will be starting our audit the first week in April.

-Together with OPRAAC and the Summer Recreation Director, we will be applying for a grant of up to \$15,000 for recreational purposes. The playground area being the priority.

-Our Casual call-in office employee has been laid off until further notice.

-I spoke with Marcus McCarthy concerning the increase in the cost of our lift stations project to see if any extra funds would be available in this regard. I haven't heard back from him yet.


