Business Arising from Minutes / Town Clerk/Managers Report

TC/M Report

-The students for summer employment have now been picked. We have five working 35 hours a week for 8 weeks which will work on the recreation programme. We have two working 30 hours a week for four weeks that will work with our public works crew.

-The lift station project has officially been awarded to Rodco Mechanical (2014) Ltd. Now waiting for the arrival of necessary equipment, due to lengthy delays it looks like work will not commence before late summer or early fall.

-The back stop on the ball field has been repaired and the sand has been put on the lines of the field.

- A representative from Harris & Associates was here today looking at our outfall and will be providing a recommendation as soon as they can get it completed.
 - -The mini-split at John Hoskins has now been fixed.
 - -The paving company should be here at any time.
- -I attended the PMA conference last week in Gander. The seminars touched on such things as Asset Management, Regionalization, code of conduct and mental health. While they did not give much detail I did pick up much information from the other town managers.
 - -Both ambulance's have now had the bi-annual inspection.
 - -The community clean-up has been arranged for Friday from 10-12am.
- -The town employees have put a team in the ball hockey tournament. This team has adopted the name of the "Town Haulers".
- -The Public Works crew received their IPAD for the Asset Management programme today.
- -The lift station that was damaged in the car accident is going to cost much more to fix than anticipated. Due to new regulations, a section of it has to be moved which will give an added expense insurance company has been notified.
- -A person from Eastern Health was here on Friday looking at our ambulance related facilities everything is fine!

Public Works Foreman(J. Younge) Report

- -The parking lot at the playground has now been completed.
- -Speed bumps will be put down tomorrow.
- -We have started ditching.
- -The road at Cook's Cove going to the pond is in the process of being widened.
 - -The public workers are all very content.
