TC/M Report

- The Public Works Crew are working on two leaks tomorrow. The water will be turned off on part of Blow Me Down Drive, so the office being included, will be closed tomorrow.
- We now have our new ambulance which is stored in the town garage for the time being.
 - The auditor was here last week and will be here again on Thursday. The audit may cost more than usual since there were many messed up accounts that were originally set up incorrectly and had to be fixed. When fixed the balances will be affected, a more in depth audit will be required.
 - Our town students have now started with the Public Works Crew. They will work on a rotational basis.
 - Flowers have now been planted throughout the Town.

- I have contacted the Dept. of Work Services and Transportation again. I am also going to contact Whitehills regarding the current state of our roads.

- I am working on a list of duties for the public workers.
- I am waiting for the Breakdown of charges from our engineer on the Cooks Cove Plant.
- We have now received the last of our benches and are waiting on the name plates. They are gradually being placed around town.
- The Public Works Crew feel that since we are down by one worker, they should contract out the ditching and any digging that may be required to fix leaks as they occur.
- I have a resident request for some beautification work on Georgie Hill. It has been suggested that an old well located there be fixed up since it is still functioning for use while on the trail.
