TC/M Report

- I have finally discovered that we do not need to put the old ambulance on tender, we can just sell it. I have confirmation that it is valued at \$7000 and have also found someone interested in buying it. It will be picked up next Wednesday.

-The Audit is still ongoing. I am now waiting for information to proceed.

-More Memorial Benches have arrived. We have some benches placed throughout the community and now waiting to hear from the others as to where they would like them placed.

-The Public Works Crew have been putting calcium on the dirt roads because some residents have been complaining. They have put up to three coats on some roads to help control the dust.

-Our Public Works crew have fixed more leaks since the last meeting. One at Marion Tizzards, and another at Mel Carters where we had to assist in replacing the curb stop that got broken. The curb stop issue resulted in the water having to be turned off for a short period of time in the lower end.

-We have a piece of the playground equipment placed, however due to the numbers using the playground and other issues we have not had a chance to complete the project. We were also helping the recreation director prepare and run the ball hockey tournament. We also had to take the dump truck to Carbonear for inspection.

-I purchased an electric led sign to go out in front of the Municipal Building which was within my spending limit.

-Our Come Home Year Celebrations were a huge success. We have heard nothing but good things. Compliments to our Special Events Committee and other volunteers and organizations -job well done! A complete report will be presented in the not too distant future.

- One of our councillors has finished his EMR training and is waiting to write his entry exam.

-I will be looking for volunteers for the Deep Blues Seafood Festival over the next couple of weeks.


