TC/M Report

-September 13, the Mayor and I had a meeting with Dave Peddle of Harris and Associates. He has agreed to help us with the application process for our outfall as well as possibly applications for other projects depending on the type of funding.

-Thursday and Friday of this week I won't be in the office as I have OH & S training. We were sent a letter stating that we were deficient in our training and that representatives of the Ambulance and Town need to update their training. It was also noted that we need an OH&S committee.

-This past weekend the casual call in and I attended the Roots, Rants and Roars festival in Elliston. We were invited to see how this festival is run and get better acquainted with it so as to have a better understanding for our Deep Blue Seafood Festival next year. The weather wasn't the best but it was good. While they have buildings at their site and are better prepared in that way, we did get some ideas as to how to improve our festival.

-We finally have the court case with a local resident concerning ongoing issues tomorrow morning. We will be attending by phone.

- -There has been no news on the lift station project as of late.
- -We did observe the Holiday on Monday in honor of the Queen.
- -The Government has created a survey on potable water in our Province mostly dealing with Manganese. I was asked if someone could come and look at our water plant. I agreed and a person came to our town last week to look at Bell Pond. They will also offer suggestions as to how to improve on what we currently have. This is all covered by the government with no cost to us.
- -For our halloween festival this year I will be picking up enough supplies for approx. 150 treat bags. Our Special Events Committee will soon be planning this event to determine what we should have and our level of involvement. I think we should look at our involvement in the Trunk or Treat activity.
