# TC/M Report

- -We haven't received any resumes for the casual call-in position but I have had several inquiries. A common question always relates to "amount" of time.
- I have heard back from the other company regarding our garbage. This company will supply a compactor. Rental cost and tow away cost will present a substantial savings for us over a year. There would be an initial set up costs but after that it will be cheaper. They are also doing up a recycling quote for me.
- I haven't heard anything else about the Deep Blues Seafood festival at this point.



- We have a meeting scheduled with Bryon Smith, our auditor, for May 16 but at this point I am unsure of the actual time.
- A meeting with the Fire Department Executive will be scheduled somewhere between either May 22-30 and July 3-24. Actual date to be determined.
- On April 21, we met with our MHA Mr. Steve Crocker and talked about a number of things. Some of which were: The state of the main road through our town, road work in our district, our infrastructure applications, health concerns around recent doctor recruitment and ambulance service, student summer employment, tourism initiatives, grants and similar programs, the current issues with the fishery and possible impacts on the region.
