- -We have identified another water line break to fix. However we have some questions we need answered before we can start repairs.

- -We have problems with the drum at Bell Pond. Lloyd was here and had the parts for it ordered. When they fix it we will have to shut down the drum for a period of time which will require us to go on a boil order for a short period of time. He doesn't believe it will be a big job to fix.
- -We are still trying to get the paving company to come here to address some of our concerns over pavement issues no luck to date never show up.
- -The Royal Greenland processing plant has now been switched back to Bell Pond as production is almost completed.
- -We had a request to patch the road at Cook's Cove but highway's have instructed us not to touch it. They stated it was a class 4 road and is not maintained. They also informed us that we are not permitted to do any work on it either.
- -This past Thursday, we had to close the office and JHCC for two hours early as we were sprayed for bug.
